INSURER CONTRACT DOCUMENTATION

This document details the contract terms entered into by the Insurers and constitutes the contract document. Insureds are advised that if any terms, clauses or conditions are unclear they should contact Grimme Butcher Jones Ltd immediately.

The Insured performs air ambulance operations in the UK and Germany under the operating names of Air Alliance Medflight UK Ltd. and Air Alliance Medflight GmbH.

INFORMATION

Planned total turnover EUR 18 million of both companies together (Air Alliance Medflight UK Ltd. and Air Alliance Medflight GmbH. Invoice total 2019 for AAMF UK flights € 7.489.279 / Invoice total for all DE flights € 17.618.043 (AAMF DE incl. AAE DE flights) = total € 25.107 Revenue base for 2020 was planned at € 31 million, whereby the corona effect will cause a decrease, therefore we should not assume more than € 22 million as a precaution.

Total number of flights in 2019 (for both companies): 855 From these flights is 1/3 Air Alliance Medflight UK Ltd. From these flights is 2/3 Air Alliance Medflight GmbH

The above ratio also fits for 2020.

The turnover share of the medical service is not more than 10%.

Air Alliance Medflight GmbH has permanently employed three (3) nurses. The doctors as well as the remaining staff (altogether about 30 persons) are freelancers. At Air Alliance Medflight UK Ltd. about 61 freelancers are listed, of which about 45 are actively working freelancers, at Air Alliance Medflight GmbH are currently 60 med. freelancers under contract.

The Air Alliance Medflight GmbH starts with 1 crew; Over the next few months, a second will follow. As in the previous year they have max. 3 crews on duty simultaneously (consisting of standby and flying crews). Depending on the order situation, more than 3 crews may be active from time to time

Subsidiary coverage is also required for these freelancers.



SECURITY DETAILS:

Insurers Liability Clause LMA 3333 as follows:

Insurer's liability several not joint

The liability of an Insurer under this contract is several and not joint with other Insurers party to this contract. An Insurer is liable only for the proportion of liability it has underwritten. An Insurer is not jointly liable for the proportion of liability underwritten by any other Insurer. Nor is an Insurer otherwise responsible for any liability of any other Insurer that may underwrite this contract.

The proportion of liability under this contract underwritten by an Insurer (or, in the case of a Lloyds syndicate, the total of the proportions underwritten by all the members of the syndicate taken together) is shown next to its stamp. This is subject always to the provision concerning "signing" below.

In the case of a Lloyd's syndicate, each member of the syndicate (rather than the syndicate itself) is an Insurer. Each member has underwritten a proportion of the total shown for the syndicate (that total itself being the total of the proportions underwritten by all the members of the syndicate taken together).

A definitive proportion (or, in the case of a Lloyd's syndicate, the total of the proportions underwritten by all the members of a syndicate taken together) is referred to as a "signed line". The signed lines shown in the schedule will prevail over the written lines unless a proven error in calculation has occurred.
